2. Indigenous Peoples' Day Commemoration

Saphire Ruiz read aloud the following speech:

"Today, we honor and celebrate Indigenous People's Day, a day to reckon with settler-colonialism and to support, defend, and fight for Indigenous People.

The history of Hamilton College is one founded on anti-Indigenous sentiments and beliefs; the land the College sits on is stolen from the Oneida people, given to Samuel Kirkland for his efforts in the Revolutionary War, accepted despite his promises that he would never take Indigenous land.

Hamilton College started in 1793 as Hamilton-Oneida Academy, a settler-colonial institution with the purpose of teaching the Oneida people assimilation into whiteness and white culture, and to turn their back behind on their own history and culture. Failing to ever retain Indigenous youth, it became Hamilton College in 1812, in the middle of yet another U.S. war, partly over land that wasn't theirs to begin with.

Despite efforts from those within it, Hamilton as an institution has failed, and continues to fail, to reckon with its past and honor the Oneida people. It fails to develop strong and genuine relationships with the Oneida, it fails to include the Oneida Nation in the decision-making processes of the institution, especially those that directly impact the land and community surrounding it, it even fails to accept and retain Oneida youth as students.

All of us are on stolen land, and all of us who are not Indigenous to what is called the "United States" has a responsibility to do our part in the returning of Indigenous land, the protection of Indigeneity, and the liberation of all Indigenous peoples."

- Parliamentarian Nomination: Gabriel Bit-Babik '25
 - Statement and questions

Gabriel Bit-Babik expressed his desire to be a part of and improve student life on campus. He believes that SA is one of the most important aspects of student life as it is a student run organization that holds power in representing students. For that reason, when he was looking at opportunities to get involved, he thought that it was necessary to do his part especially with the turbulent times going on currently in SA. He mentioned that he will do the best he can to be impartial, to be objective to everyone's concerns, and to be a resource for all Assembly members. He emphasized that he is here for everyone to make sure the assembly is the best and most efficient body it can be for students and hopes that he can be confirmed.

Cole Kuczek asked if Gabriel Bit-Babik saw any points in the constitution that can be addressed or improved.

Gabriel Bit-Babik responded that there are many parts of the constitution that may be revised, which is what the Assembly may want to consider. He has talked to other members of the assembly regarding this and mentioned that he is happy to consult regarding this if someone wants to talk about this more deeply. In terms of his personal opinions, he wants to see the Constitution be more efficient and representative of the campus along with being more inclusive. He would be in favor of constitutional changes if it's the will of the Student Assembly.

Jackson Harris asked how familiar Gabriel Bit-Babik is with the Constitution.

Gabriel Bit-Babik replied that he had read the Constitution even before the Assembly asked him to serve as Parliamentarian. He mentioned that he is also becoming more and
